Campers, Trailers, RVs	Campers, boats, trailers, or any other similar vehicle shall be garaged or screened from neighbors' view behind the residence. (Article V, Section 9)	
Clothes Lines Allowed	No outside clotheslines shall be permitted. (Article V, Section 18)	
Drainage channels	No Lot Owner shall place fill on any lot or place fences, trees or landscaping in such a location of position that will interfere with the existing drainage on or from other Lots or the Common Areas. (Article V, Section 32)	
Exterior Artwork	Lawn ornaments, including but not limited to statues, fountains, decorative flags and benches a expressly prohibited. (Article V, Section 35)	
Fences: chain link allowed?	No	
Garage Sales permitted?	There shall be two (2) annual yard/garage sales comprising all property owners. No yard sale signs, except signs advertising the annual joint subdivision yard sales are allowed. For this paragraph, yard sales and garage sales are synonymous. All other sales from private residents are prohibited. (Article V, Section 39)	
Mailbox and post (if any)	All mailboxes shall be of uniform size, color and design as determined by Developer. Non-conforming mailboxes shall not be permitted. Parking restrictions:	Cars, trucks and other automobiles shall be kept in the owner's garage or driveway. PARKING OVEHICLES ON PUBLIC STREETS OR ALLEYWAYS BY OWNERS IS PROHIBITED EXCEPT FOR LOADING AND UNLOADING PURPOSES. THERE SHALL BE NO PARKING IN THE YARD, ON THE SIDEWALK OR THE GRASS BETWEEN THE ROAD AND THE SIDEWALK. (Article V, Section 41)	
Pool	graphical depiction identifying size, shape, location, materials, and all other matters appurtenant to a swimming pool must be submitted to the Architectural Review Committee for a plan approval prior to the installation of the same. No above ground or on ground pools are permitted. Landscaping shall be provided to reduce the visual impact of the pool from public streets and adjacent neighbors. Pool pumps and equipment shall be substantially screened from view and located so as not to be a noise nuisance to adjacent neighbors. Screened enclosures of pools are not permitted. Pool fences to be standard style as approved by the Architectural Revi Committee and must meet local code requirements. Inflatable/Kiddie pools no larger than eight (8) feet in diameter and two (2) feet in height are allowed so long as they do not remain outdoors for more than seven (7) consecutive days and situated at the rear of the property. Residential Purposes Only	No lot may be used for any purpose except for the construction and maintenance of a residenti building of traditional design. No such residential structure on any such lot shall be designed, constructed or used for more than one family. (Article 1, Section 1)	
Satellite dishes/TV antennas	Satellite dishes shall be no larger than one (1) meter maximum size and attached to house in a low or no visibility location. The location must approved by the Architectural Review Committee and before installation is commenced, a submittal showing location is required for approval. (Article V, Section 16)	
Trampolines Allowed	Trampolines shall be designed to be flush mount with the ground. The trampoline and any safe netting shall not be visible from any street. (Article V, Section 22)

Vehicle Storage	All recreational vehicles, all-terrain vehicles, motor homes, dirt bikes, trailers, golf carts, commercial vehicles, enclosed trailers, hauling trailers, motorcycle trailers, boats, personal wat craft and/or yard mowing equipment, must be kept in garages or screened from view of all neighbors and from the front view of the house. The storage of said vehicles shall be subject to the approval of the Committee. No inoperable or junk vehicles shall be parked on any lot, nor on the street. All licensable vehicles shall have current license plates and registration. No tractor-trailer bed or comotor home, commercial truck or vehicle over 20 feet in length, school bus, or recreational vehicle shall be parked on any Lot or public street in this subdivision.
